Contract Agreement

THIS AGREEMENT made the 7th day of July 2022 between **Coal Power Generation Company Bangladesh Limited (CPGCBL), Unique Heights (level-17), 117-Kazi Nazrul Islam Avenue, Eskaton, Dhaka-1217** (hereinafter called "the Procuring Entity") of the one part and **M/S. Jashim Traders, 158, Shahid Sayed Nazrul Islam Sharani, Purana Palton, Dhaka-1000.** (hereinafter called "the Contractor") of the other part:

WHEREAS the Procuring Entity invited Tenders for certain works, viz, **Construction of Boundary Wall & Waste Water Disposal Works for Resettlement Houses at Matarbari 2x600 MW Power Project Area** and has accepted a Tender by the Contractor for the execution of those works in the sum of **Taka 13,19,706.867 (Thirteen Lac Nineteen Thousand Seven Hundred and Six Point Eight-six-seven)** only including VAT & Tax, (hereinafter called "the Contract Price").

 - g) the Bill of Quantities
 - h) any other document including correspondences listed in the PCC forming part of the Contract.
3. In consideration of the payments to be made by the Procuring Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Procuring Entity to execute and complete the works and to remedy any defects therein in conformity in all respects with the provisions of the Contract.
4. The Procuring Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the works and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
