## Contract Agreement

THIS AGREEMENT made the 11th day of July 2021 between Coal Power Generation Company Bangladesh Limited (CPGCBL), Unique Heights (level-17), 117, Kazi Nazrul Islam Avenue, Eskaton, Dhaka-1217., (hereinafter called "the Procuring Entity") of the one part and M/s.   - (b) the Notification of Award;
  - (c) the Tender and the appendices to the Tender;
  - (d) Particular Conditions of Contract;
  - (e) General Conditions of Contract;
  - (f) Technical Specifications
  - (g) Drawings
  - (h) Price Schedule and Schedule of Requirements and;
  - (i) other document correspondence listed in the PCC forming part of the Contract.
3. In consideration of the payments to be made by the Procuring Entity to the Contractor as hereinafter mentioned, the Supplier hereby covenants with the Procuring Entity to provide the goods and related services and to remedy and defects therein in conformity in all respects with provisions of the Contract.
4. The Procuring Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and related services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
