## Contract Agreement

THIS AGREEMENT made the 12<sup>th</sup> day of September 2021 between *Coal Power Generation Company Bangladesh Limited (CPGCBL), Unique Heights (level-17), 117-Kazi Nazrul Islam Avenue, Eskaton, Dhaka-1217* (hereinafter called "the Procuring Entity") of the one part and *STEEL CORE, House-53, Road-3, Janata Housing, Ring Road, Adabar, Dhaka-1207* (hereinafter called "the Contractor") of the other part:

WHEREAS the Procuring Entity invited Tenders for certain works, viz, *Supplying, Fitting and Fixing of Cabinet for CPGCBL Corporate Office* and has accepted a Tender by the Contractor for the execution of those works in the sum of *Taka 8,78,065.048 (Eight Lakh Seventy-eight Thousand Sixty-five Point Zero-Four-Eight) only including VAT & Tax*, (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the General Conditions of Contract hereafter referred to.

  - a) the signed Form of Contract Agreement
  - b) the Notification of Award
  - c) the Complete Tender and the appendices to the Tender
  - d) the Particular Conditions of Contract
  - e) the General Conditions of Contract
  - f) the Bill of Quantities
  - g) any other document including correspondences listed in the PCC forming part of the Contract.
3. In consideration of the payments to be made by the Procuring Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Procuring Entity to execute and complete the works and to remedy any defects therein in conformity in all respects with the provisions of the Contract.
4. The Procuring Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the works and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
